Los Angeles, CA-The Alliance for California Traditional Arts (ACTA) will celebrate the opening of its Southern California office on August 21, 2012 from 6:00- 9:00 p.m. at Grand Performances at California Plaza in downtown Los Angeles. This event, produced in association with Grand Performances, will offer an evening of convivial traditional arts sharing by several performing and visual artists drawn from ACTA's 15-year program history in the region. Together, ACTA's board, staff and some of southern California's traditional cultural treasures will impart the story of ACTA and its important work.

We will also introduce the new program manager Quetzal Flores, who was hired after conducting a national search and open application process. Flores brings extensive experience as a community organizer, cultural worker, and accomplished artist. As a program manager he will work to deepen and expand ACTA's work in the Southern California region from ACTA's new downtown Los Angeles field office that is co-located with Community Partners at The California Endowment.

The Alliance for California Traditional Arts (ACTA) was founded specifically to address a void in statewide support of folk and traditional artists. Since its founding in 1997, ACTA has worked to promote and support ways for cultural traditions to thrive now and into the future by providing advocacy, resources, and connections for folk and traditional artists. Folk and traditional artists are tradition bearers: people who transmit what they believe, know, do and create with others who share a common heritage. From Cahuilla bird singing and African-American quilt-making to cowboy poetry and Vietnamese opera, California is home to hundreds of diverse traditions. ACTA awards grants and contracts to individuals, unincorporated groups and non-profits to support a wide array of community-based cultural expressions. To date, ACTA has supported over 600 traditional artists and groups with over \$2.8M in 45 California counties.
